Minutes of the meeting held on February 23, 2016 Prepared by Dora Parks, Committee Secretary

#### CALL TO ORDER AND INTRODUCTIONS

Chairman Kevin Woolbright called the regular monthly meeting to order at 9:33 am followed by the customary introductions.

The minutes of November 24, 2015 were approved as written.

#### **OLD BUSINESS**

None reported.

# OPEN DISCUSSIONS REGARDING DAMAGE PREVENTION AWARENESS & COOPERATION

Mitzi Ambush (PEPCO) brought (3) District of Columbia issues to the committee;

Private locators working at the national parks are excavating without tickets. PEPCO is sustaining damages, one damage affected the power to the White House gate operations. Secondly, Contractors conducting demolition work without tickets. There were (3) incidents of this negligence. The contractors were found to be pulling underground energized power lines creating a dangerous work site and flung a gas meter over a fence. Thirdly, some excavators are not maintaining the marked work site and working without marks causing PEPCO hits. Mitzi stated the importance of contacting the utility owner/operator of a hit/damaged line and to stay on site until they arrive. It is vital to not cover the damage and leave the site. Mitzi thanked DC Water and WGL for their collaboration on damage alerts and unsafe excavation practices; Mitzi stated these utilities are working towards a beneficial relationship.

Dora Parks (Miss Utility) provided information on how to request a work site re-mark via Miss Utility. ITIC provides a menu function for re-mark notices using a valid ticket number or the excavator can process the re-mark ticket using a call center CSR. The notice carries a two-day response time; Dora suggested the excavator call the utility locator and work out a schedule for the site re-mark if needed in less than 2 business days.

There was a general discussion regarding re-marks during the recent snow events of January and February. The group agreed that communications is key when dealing with these issues.

Other group concerns and discussions included;

Out of state excavators working in Maryland and not knowing Maryland law, many are digging without tickets. Some utility locators not responding to re-mark tickets.

Excavators requesting flags in addition to paint marks and not getting them. (This may be due to frozen ground, community issues, children areas and weather conditions.)

Damages to privately owned lines.

Do quarry sites need a ticket? (Yes, if they disturb the earth Maryland Law requires a ticket.)

Can an excavator continue to work on an update ticket without waiting the 2 business days? (Not according to Maryland law.)

Can the Discrepancy and Dispute excavator Ticket Check codes allow comments? (Subscribers addressing this topic.)

Work site white lining responsibilities. (Extent of work text on the ticket trumps the site white lining.)

Chairman Kevin Woolbright suggested that the excavators meet with the utility locators after the meeting to resolve some of the locating and site requests issues.

# PRESENTATION, TRAINING AND EDUCATION

Dora Parks provided information on the hazards of driving in bad weather conditions in light of the recent weather Maryland experienced in January and February (snow, ice, frozen conditions and heavy rains). The Bureau of Labor Statistics reported for 2014, there were 89 fatalities per day across the nation due to poor driving conditions. The ytube video displayed many vehicle accidents and near hits due mostly to icy road conditions, driving too fast and the impact on other drivers when a vehicle loses control. The presentation was well received by the meeting attendees.

Oral Arguments for NPV# 283 on the Constitutionality of the Authority were heard in front of the Maryland Court of Appeals, the highest court in Maryland on January 8, 2016. Waiting for an opinion

NPV's 316a, 316b, 408, 411a, & 411b. Oral Arguments were heard in front of the Maryland Court of Special Appeals on October 13, 2015. An unfavorable opinion was rendered on October 22, 2015. A brief was filed to take the opinion from unpublished to publish, request denied. The Authority voted to not appeal that opinion.

NPV's 1216, 1834, 1841 and 1853 were scheduled for Oral Arguments in front of the Circuit Court of Anne Arundel County on January 4, 2015; however, a stay has been requested with no date set.

Marcia Collins, Vice Chair – Maryland Association of Counties – will not seek re-appointment. Jim DiPietro of Anne Arundel Co. DPW will be seated at the March 2, 2016 meeting

Veronica Davila-Steele – General Public – Re-appointment

Walter F. Gainer – Public Works Contractors Association – term limited. George "Bucky" Taylor was seated at the December 2, 2015 meeting to replace Walter.

Thomas L. Hastings – MD/DC Damage Prevention Committee Locating Contractor was re-appointed. Kevin Woolbright, Chair – MD/DC Subscribers – term limited. Charles McCadden of BGE will be seated at the March 2, 2016 meeting to replace Kevin.

Thank you Kevin Woolbright for 5 years of service on the Authority and as Chair the last two years

The Authority is sponsoring legislation in 2016 to add \$0.05 to all outgoing tickets (excluding MACo & MML) to fund the Authority.

SB 480 had hearings on 2/16/16 and passed unanimously in the Senate Finance Comm.

HB 696 had hearings on 2/18/16 but no vote as of yet

The Authority received another \$100,000 State Damage Prevention Grant from PHMSA for the Grant Year September 30, 2015 through September 29, 2016.

# LOCATOR ACHIEVEMENT AWARDS (LAA) AND DIG SMART AWARDS (DSA)
