OPEN DISCUSSIONS REGARDING DAMAGE PREVENTION AWARENESS & COOPERATION

Becky Mellinger (Childs Landscape) began open discussion by complimenting Mike, a Utiliquest supervisor from Prince George's County, on his super communication skills and desire to work with Becky on a particular project. She also shared that Miss Utility lip balms have been a great marketing tool for Childs Landscape.
