Minutes of the meeting for November 26, 2019 Meeting hosted by Miss Utility in Hanover, MD Prepared by Susan Sullivan (Miss Utility)

CALL TO ORDER AND INTRODUCTIONS

Chairman Kevin Woolbright called the regular monthly meeting to order at 9:30 a.m. followed by the customary self-introductions.

APPROVAL OF MINUTES

The minutes of September 24, 2019 were approved as written. The approved meeting minutes will be posted at https://www.missutility.net/excavators/.

OLD BUSINESS

Dora Parks (Miss Utility) reviewed the call center process for filing a Discrepancy. Please be reminded that after submitting a locate request, it is the responsibility of the excavator to confirm that all appropriate owner-members are listed on the locate ticket and that each positive response is confirmed and accurate. If an owner member is not listed on a locate request, the excavator must call the call center and have the owner member added to the ticket. In addition, if a status code of marked or clear/no conflict is inaccurate, the excavator must file a discrepancy. A properly filed discrepancy is then sent to the owner member or contract locator to initiate an open line of communication.

Enhancements to the Discrepancy/Dispute code will allow for both comments (describing the discrepancy) and attachments. Both enhancements are designed to allow for improved and timelier communication between locator and excavator. The addition of a Trenchless Excavation field will go into effect with the Discrepancy/Dispute enhancement. Both are scheduled to take effect by the end of 1st quarter 2020.

ITIC.nxt testing continues. The principal benefit to this software update is that all mapping can take place during one (1) mapping session with the software splitting tickets up according to preset split-rules. This allows for a smoother, quicker ticket processing experience. Once released, ITIC.nxt and ITIC 2.0 will operate in tandem for a period of time. ITIC.nxt training from Miss Utility will be provided using multiple platforms.

NEW BUSINESS

Becky Mellinger (Childs Landscape), via an email to Dora Parks, wanted to extend a big thank you to and compliment Utiliquest, USIC and Broadband for the noted effort in catching up on an observed increase in tickets over the last few weeks and for their support on several difficult street tree projects. The supervisors and locators she spoke with were great and she appreciates the extra help.

Dora Parks complimented Comcast, Verizon and Broadband for their attention and response to an HOA complaint that led to the removal and replacement of numerous unidentified, damaged and unattractive cable boxes. Due to the collaboration of those involved, the boxes in question now have an improved look and homeowners are pleased.

OPEN DISCUSSIONS REGARDING DAMAGE PREVENTION AWARENESS & COOPERATION

Mary Hill (Ferguson Trenching) thanked Dave Miller (BGE) for the damage prevention training her team recently received. She also gave an update on billing concerns Ferguson is having with Verizon and Utiliquest. Dwayne Stine (Verizon) offered his assistance in resolving the issue.

Felix Villa (J. Villa Construction) spoke of tickets not being cleared then being statused a code 10 just before expiring. Nieal Hollingworth (USIC) and Dave Miller (BGE) both offered assistance.

Bill Jackson (MDOT/SHA) introduced himself and offered assistance to anyone with MD State ROW or permitting questions. Dora Parks reminded attendees that MDOT/SHA are only notified of a locate request if the answer to the MD ROW question is yes and correct agency and permit numbers are submitted.

SAFETY PRESENTATION

Patrick Hager (RK&K Engineers) presented an overview of the Purple Line which is a 16-mile light rail line that will extend from Bethesda in Montgomery County to New Carrollton in Prince George's County. In addition to explaining the difference between road widening and railway system construction, topics covered included: Project Scale Information / Project Status; Design Challenges and Keys to Success; Magnitude of Utility Relocation; Project Photos and Project Highlights. Revenue Service is scheduled to begin in late 2022.

- Doug Levine, the MACo representative on the Authority has resigned his position. The Authority is still waiting on Appointment Letters for Amber Brengel, PWCA representative; Joyce Brooks, Public representative and Erik Phillips, Locator representative.
- The Authority has adopted a "Warning Letter" Policy. Letters have been sent to Orkin, Down Underground and C&M Underground.

The next Maryland Authority meeting will take place on December 4th at 9:00am at the Miss Utility Call Center. One formal hearing is scheduled. These meetings are open to the public and very informative. Please plan to attend.

MARYLAND TITLE 12 RE-WRITE

- The Title 12 Re-Write working document from November 30, 2018 has been submitted to Legislative Services by our lead sponsor, Delegate Dereck Davis, to be drafted into Legislative Format. Senator Brian Feldman, Vice-Chair of the Senate Finance Committee is our lead sponsor on the Senate side. Susan Shroud (MD Authority) has prepared a White Paper that is currently being reviewed and will be available sometime in December.
- The Maryland Title 12 Re-Write will be submitted to the Maryland Legislature during the 2020 Legislative Session.
