Minutes of the meeting for January 28, 2020 Meeting hosted by Miss Utility in Hanover, MD Prepared by Dora Parks

CALL TO ORDER AND INTRODUCTIONS

Chairman Kevin Woolbright called the regular monthly meeting to order at 9:31 a.m. followed by the customary self-introductions.

APPROVAL OF MINUTES

The minutes of November 26, 2019 were reviewed by the committee; Jack Ellison (WGL) made a motion to accept the minutes as presented. Pam March (SMECO) seconded the motion, the motion carried. *The approved meeting minutes will be posted at <u>https://www.missutility.net/excavators/</u>.*

OLD BUSINESS - No Reports

NEW BUSINESS

Matt Ruddo voiced a desire to have electronic damage prevention training implemented in the Miss Utility footprint in 2019. Other states (NY, VA, IN) have successfully executed an on-line training module. Matt reported that NY started in 2019 with 1,500 folks working through the training module receiving wallet size certificate cards. The Maryland Authority has received grant money to be used for this initiative; Matt suggested a collaboration between Miss Utility and the Authority for this purpose. Matt stated there is a surplus of money in the GCDPTC account and that perhaps some of this money could be used to create the new training module. The committee provided a favorable response to this information and proposal. Matt will share this collaborative proposal at the next GCDPTC committee meeting for their consideration of conference surplus money being used for this purpose. The DPC committee suggested a Spanish online training module be considered.

OPEN DISCUSSION

Per Mitzi Ambush, PEPCO is experiencing damages due to excavators not waiting for marks; in addition to foremen/supervisors not filtering ticket and Ticket Check information to working crews. A contractor used a hammer to determine if a utility duct bank was energized and/or pressurized. Other recent damages included vac excavation damages and the subs leaving the work site after the damage occurred.

There was a lengthy committee discussion regarding vac excavation as a safe method of working around the buried facilities/utilities with regards to an air knife and water pressure. The group agreed that all users should exercise due care and get training if they own the equipment or hire reputable vac companies.

Joe Shelton (BF Joy) stated that DDOT is not supporting safe excavation in the District as they have not been locating tickets for some time. Joe believes it is time to ensure the District politicians are aware of

this practice and suggested the contractors pull together and seek the support of the Mayor and City Council. Deborah Harvey (ED of NUCA, DC Chapter) asked excavators to share their DDOT damage data with NUCA; NUCA is working to bring awareness of this matter for a positive outcome in the near future.

SAFETY & EDUCATION PRESENTATION

Winter Driving Hazards, presented by Dora Parks (Miss Utility)

Several videos were shown outlining the hazards of winter driving on black ice, snow and heavy rain storms. Information was provided on vehicle emergency supplies that included; water, food, blankets, flash lights, ice scraper, shovel, sand/kitty litter, hazard triangles, first aid kit, jumper cables and a charged cell phone. The video also explained proper vehicle maneuvering during ice conditions. Planning for the unexpected could mean the difference between a life-threatening situation and an inconvenient one. The committee elaborated on drivers who do not clear their windows or top of vehicle and driving too fast in storm conditions.
