Minutes of the meeting for September 27, 2022 Hybrid Meeting hosted by Miss Utility in Hanover, MD Prepared by Susan Sullivan

CALL TO ORDER AND INTRODUCTIONS

Jesus Cruz (CW & Sons) shared that he has found the National Park Service uncooperative and uses private locates, when necessary, within the National Park Service territory.

Shelly Welling (Gray & Son) applauded BGE's Damage Prevention Hotline @ 410-470-6200. Marc Haines (BGE) followed up by explaining that this number bypasses BGE's customer service call center providing quicker damage prevention access to callers. This number, however, is not for emergencies.
